
Section 604(b) of the Clean Water Act provides approximately 1% of <u>Clean Water State Revolving Fund</u> <u>allotments</u> (or \$100,000 if greater) to support State water quality planning activities under 205(j) and 303(e) of the Act.





2021 - Bipartisan Infrastructure Law (BIL) also known as the Infrastructure Investment and Jobs Act signed.

New guidelines to help states and territories build on their successes and more fully integrate equity, environmental justice (EJ), and climate considerations into water quality planning efforts.



Who is eligible

EPA: regional public comprehensive planning organizations (RPCPOs) and appropriate interstate organizations (IOs)

Designated PLanning Agencies (DPAs)

Maricopa Association of Governments - MAG Pima Association of Governments - PAG Northern Arizona Association of Governments - NACOG SouthEastern Association of Governments - SEAGO Central Arizona Governments - CAG LaPaz County Mohave County

<u>Also</u>

Council of governments Counties, conservation districts Cities and towns







Historically:

- improving stormwater systems
- determining ways to expand green infrastructure programs
- determining the nature, extent and causes of point and nonpoint source water pollution problems, and developing plans to resolve these problems

New emphasis in 2022

• Targeting funds towards equity and climate

Planning only - not implementation

Examples of past recipients 2021/2022



Town of Kearney: Kearney Lake: Planning for improvements - \$6,405

The lake is a centerpiece of this town. However, the lake is unhealthy and fish do not survive. Study to determine the cause and plan for improvements to make it safe for fishing and swimming.



CAG: Pinal County Septic System Location Study - \$60,595

identify, quantify, and qualify septic systems and their impact on nearby water sources in rural areas of Pinal County. Analysis will include guidance documents for communities on remediation measures and possible funding opportunities to protect groundwater drinking supplies. The data collected will also be used for public education campaigns for Best Management Practices for septic system users.




Town of Pinetop-Lakeside - Billy Creek Watershed Assessment and Outreach. \$80,000 - *pending*

NACOG - Upper/Middle Verde Watershed Effluent Generation and Stormwater Infiltration Optimization Plan
