Funding Mechanisms for Stormwater – Choices...

- General Fund
- Federal and State Grants
- New Development Fees
- Component of Water, Sewer, and/or Solid Waste Utility
- Direct Fee for Service (Utility or Regulatory Fee)
 - Dedicated Balloted Tax
 - Govt' vs Voter initiative

Other approaches

Funding Mechanisms – Utility Funded Van

- Only requires passage of an ordinance.... ...with County Commissioners/City Council approval
- 1. Communications plan and implementation to:
 - a) Decision makers
 - b) Community
- 2. Develop Rate methodology approach
 - a) Engineering Study
 - b) Rigorous, detailed budgeting
- 3. Governing Agency Approval
- Political cover...consider a survey
- ...Compared to California...

 - as Voter initiative
- Mechanisms
 - Flat Rates
 - Gas Tax
 - Sales Tax
 - % of Assessed value (mil rate)
- When?

- Opposition?





Voter Approved – Process

- Governing Agency
 - Pass resolution
- Voter Initiatives
 - Collect signatures
- Considerations





Voter Approved – More Process

- 1. First Draft Measure and Messaging
- 2. Conduct Survey to answer
 - When
 - Rate
 - Details
 - Outreach
 - Funding
 - Opposition
- 3. Administrative Tasks
 - Registrar of Voters
- 4. Communications and Outreach!
- 5. Use consultants or in-house?



California's plan^B Process

Property Related Fee - Proposition 218 Process

- 1. Determine Rates (Fee Study)
- 2. Mail Notice of Hearing
- 3. Conduct Hearing
 - a) Majority protest can stop process
- 4. Mail Ballot Packet
- 5. Tabulate Votes & Final Action



Other Funding Mechanisms – Re-Alignment Examples

- Green Streets and Transportation Projects
- Multi-Benefit
- Existing Documents and Plans



Communications – Final Thoughts

- Be more political! Lean in!
- Elected Officials (Utility) vs. Community (Balloted)
- Details, financial and engineering rigor, authenticity
- Storm Drainage Messaging
 - Prevent local flooding
 - Rebuild our local infrastructure
 - And protect environment while we are doing it.
