

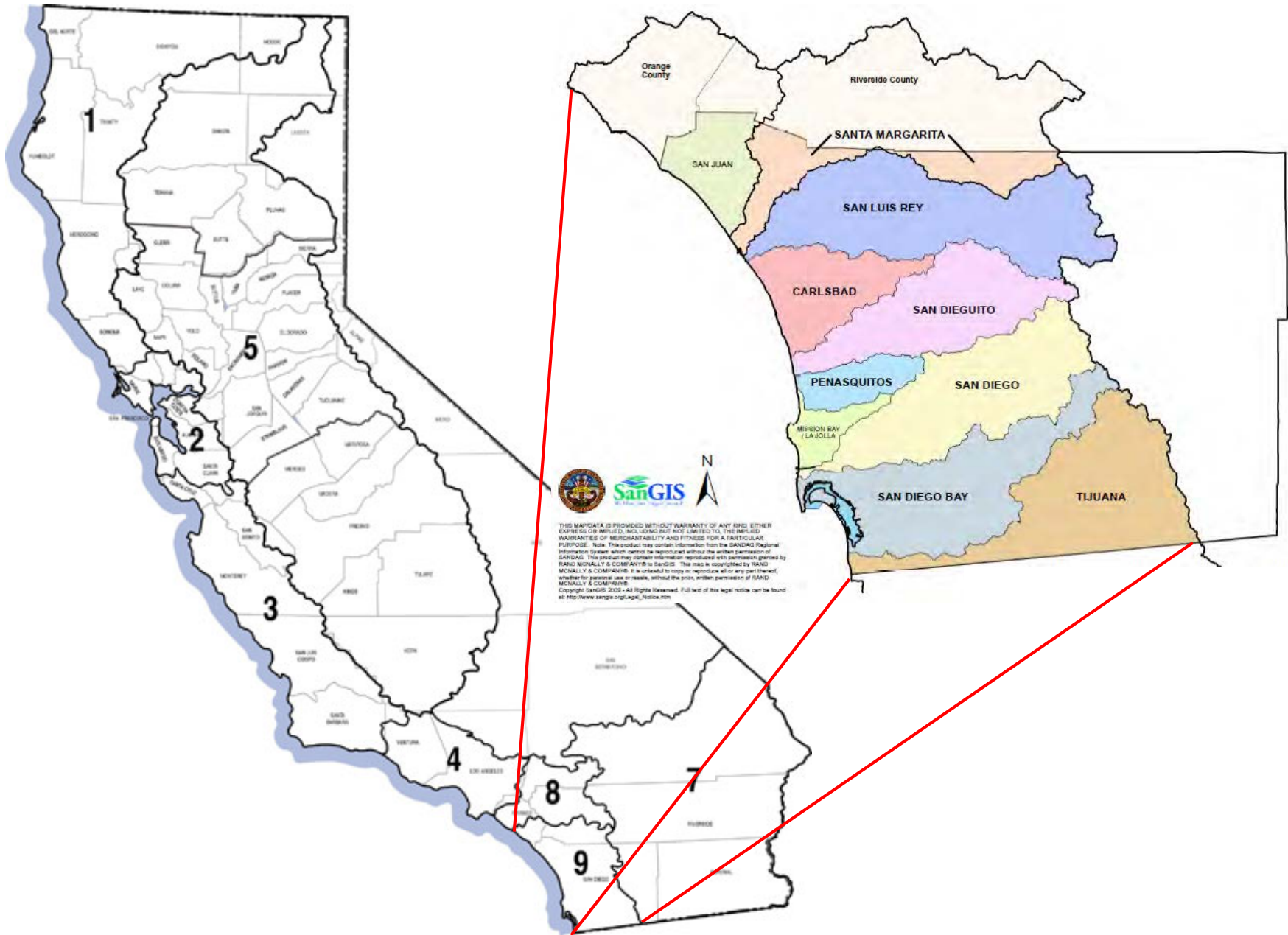

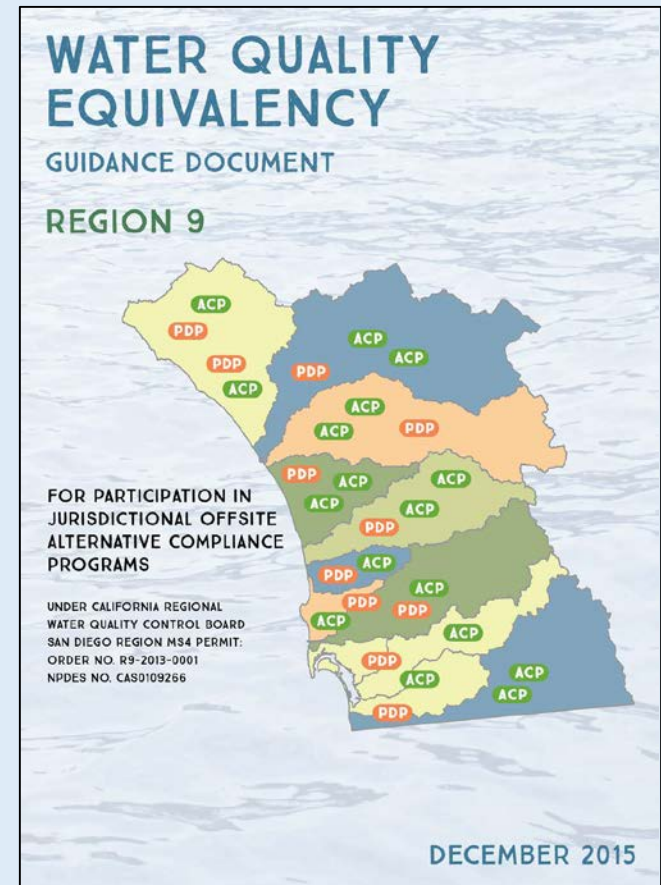
Regional MS4 Permit Allows

- Alternative Compliance Land Development
- In-Lieu Fee Program
- Water Quality Crediting Program

Funding Storm Water San Diego Water Board *Style*

- Just Getting Started
 - Phase I Guidance Finalized - Dec 2015
 - Phase II Guidance Under Development – Dec 2017
- Requires Greater Overall Water Quality Benefit



Funding Storm Water San Diego Water Board *Style*

➤ In-Lieu Fee Structure

- Not much discussion on this yet !
- Fee Structure Developed either
 - Individual Copermitttee
 - Multiple Copermitttees
- Fees must be transferred Prior to Construction
 - Copermitttee for public projects
 - Escrow account for private projects

Funding Storm Water San Diego Water Board *Style*

Water Quality Crediting Program

➤ Currency

- Pollutant Control = Volume
- Hydromodification = Directly Connected Impervious Area Effectively Managed

Funding Storm Water San Diego Water Board *Style*

➤ Challenges

- Timing
- Quantifying stream restoration credits
- Partial crediting
- Keeping it simple
 - Usable by smaller Copermitttees
 - Consistently applied
 - Auditable
- Ensure water quality improves **FASTER**

Funding Storm Water San Diego Water Board *Style*

➤ Looking for Advice

- Reducing fear
 - TMDL compliance – regulatory transparency
 - Third party law suits
 - Cross jurisdictional liability
- Manage / Track it
 - So credits don't get sold twice
 - Audit for compliance
- Keep it simple
